SUBJECT: Announcement of the Joint Evaluation of the National Security Agency Integration of Artificial Intelligence (DoD OIG Project No. D2021-DEV0SI-0152.000; NSA OIG Project No. EV-21-0011)

We are announcing the subject evaluation, as a joint evaluation with the National Security Agency Office of Inspector General. The evaluation objective is to assess the National Security Agency's integration of artificial intelligence into signals intelligence operations in accordance with DoD and Intelligence Community guidance for artificial intelligence. We may revise the objective as the evaluation proceeds, and we will also consider suggestions from DoD and National Security Agency management on additional or revised objectives. We previously announced an evaluation of the National Security Agency's Integration of Artificial Intelligence in August 2020; however, that evaluation was terminated July 2021 (see attachments).
